The Claimant's staff who work at Greenwich House were able to re-occupy Greenwich House on 8 January 2025, following the Defendant's occupation and a period in which the aftermath was assessed and dealt with (including a deep clean and electronic sweep), and thereafter carry out an audit of the documents held in the Research Operations Office (ROO) to assess what documents may have been inspected by the Defendants and the nature of the information contained in those documents.
2.	There are a significant number of documents to review by various individuals who work within the ROO, which has needed to be carried out alongside their usual duties, so this has taken some time.
3.	Good progress has been made with the audit to date which has allowed the Claimant to draft the Particulars of Claim but further reviews and assessments around the audit are necessary to prepare witness statement(s) ahead of the review hearing.
